1.SCOPE OF WORK

2. The bidder should have valid GST Registration
3. The period of the contract is one year from the date of issue of work order.
4. The bidder shall remit the tender form cost and EMD as given in the tender document. The bids without remitting tender form cost and EMD will be rejected.
5. The rate quoted shall be inclusive of travel , lodging etc.
6. The rate quoted shall be exclusive of GST and the GST applicable should be mentioned at the space provided in the Price format. If the bidder is below the threshold limit of GST that should be mentioned in the price format and a self declaration shall be submitted with the tender.
- 7..
