**Name of work: "Construction of Pits and Drain at Post Precipitation Filtrate Pump Area at TTPL"**

**1. Scope of work:** The scope of work includes:-

- Construction of pit and drains (Pit 1) at TiO<sub>2</sub> Plant near Post Precipitation Filtrate Pump. Work includes in major RCC, AR Brick laying and AR Tile laying.
- Details of the work shall be referred to the attached BoQ/ Estimate (Page No. 6)
- Construction materials such as Acid Resistant Bricks (AR Bricks), Acid Resistant Tiles (AR Tiles) and Corromastic will be supplied by TTPL. All other construction materials except for the above mentioned are at contractor's scope.
- The contractor shall provide all necessary labour, equipment and management and supervisory personnel to complete the works provided under this contract in time.

**2. Quantity:** Detailed in Proforma (Page No. 6).

**3. Price: The rates should be quoted only in the Proforma enclosed** (Page No. 6. The quoted rate of Contractor must be firm and shall be inclusive of cost of transportation of material to the site and all applicable taxes of State Government as well as Central Government.

The rates quoted by the Contractor shall be firm throughout the Contract period and there shall be no upward revision of the rates quoted by the Contractor for any reasons whatsoever. It should be clearly understood that any claims for extra Goods and Service Tax, or any Additional tax, etc., shall not be entertained in any case whatsoever once the tenders are opened.

- 4. Completion Period:** The work should be completed within **One month** from the date of issue of Work Order. The work should be commenced **immediately** from the date of issue of Work Order.
- 5.** The company is no way responsible for any loss or damage to the materials entered in TTPL campus by the contractor.
- 6.** All the balance materials, unserviceable & unwanted materials should be removed and cleared the work site at the end of every day. Unserviceable materials should be dumped in earmarked yards as per the instructions of the officer in charge. The work site must be cleaned before submitting the bill.
- 7.** Payment will be made after satisfactory completion of the work with the recommendation of the officer in charge.
- 8.** It is entirely the contractor's responsibility to provide all safety equipment wherever necessary to their workmen. The Company is in no way responsible for any injury, disability or death of contractor's workmen due to non-compliance of safety regulations.
- 9.** TTPL reserves the right to accept/ reject any of the tender after evaluation with or without assigning reason no matter whether a Tenderer has quoted the lowest rate. All questions/disputes arising out of or in connection with this shall be decided by the Managing Director of the company and his decision thereof shall be final and binding to all tenderers.

10. Tender should bear the signature of the Tenderer in all pages.

11. **The rate quoted shall be exclusive of GST and the % of GST applicable should be mentioned at the space provided in the price Proforma. No subsequent claim will be entertained.**

12. It is no binding on the company to accept the lowest offer. The company reserves the right to cancel/postpone the tender or to reject any or all offers without assigning any reason.

13. The tenderer should remit the Earnest Money Deposit (EMD) mentioned in this document in cash/DD and proof of thereof should be enclosed along with the tender. Other mode of remittance will not be accepted. Exemption in Tender Form Cost and EMD is as per Govt. rules.

#### **14. Security Deposit**

Within 15 days of award of contract, the successful tenderer shall deposit a sum equivalent to 3% of total contract value towards Security Deposit. This shall be paid in the form of Demand Draft in favour of Travancore Titanium Products Limited payable at Thiruvananthapuram from a nationalized bank. Security Deposit is also acceptable in the form of a Bank Guarantee as per TTPL Proforma, which shall be supplied on request. Bank Guarantee from Nationalized bank registered in India alone will be accepted. The Security Deposit shall be returned after satisfactory completion and acceptance of all works included in this tender unless the same is forfeited by the company for any breach or towards any amount due to the company.

On completion of Defects Liability Period of six months, the Engineer-in-Charge shall recommend on demand from the Contractor to refund to him the security deposit and the same will be refunded by the Travancore Titanium Products Ltd. provided that the Engineer-in-Charge is satisfied that there is no demand outstanding against the contractor.

The security deposit will not carry any interest and will be refunded after the completion of all contractual obligations including guarantee period. On default of the tenderer to remit the Security Deposit and sign the Agreement, the EMD withstand forfeited and if any loss or damage is sustained by the company in this regard, the same will also be recovered from him.

#### **15. Agreement**

The Contractor should execute an agreement with TTPL in non-judicial stamp paper worth Rs.200/- as per TTPL Proforma, which shall be supplied along with Work Order. The EMD is liable to be forfeited in case the bidder fails to execute the Agreement within 15 days from the date of receipt of Work Order.

**16. Payment Terms:** Payment will be made after satisfactory completion of the work as certified by the Engineer-in-charge

All payments are made, after deducting there from income tax and other amounts as may be deductible or recoverable in terms of the contract or the laws in force.

Income tax at the rate prevailing at the time of payment will be deducted from each running bill and final bill.

All statutory payments in connection with the employment of the workmen for this work will be borne by the Contractor.

Signature of the Tenderer:

All statutory deductions at the rates applicable shall be made from the amount eligible to the Contractor in each part bill at current rates. Any tax omitted to be deducted in any part bill shall be deducted in the subsequent bills/final bill or from any amount due to the Contractor.

The contractor shall produce all necessary documents from the Goods and Service tax department.

17. If any irregularity or fraudulent behavior is noticed on part of the contractor/ his agents/ representatives or the crew of the vehicle engaged by the contractor for the performance of the contract, the company reserves the right to take all suitable action deemed fit against the contractor and those concerned.
18. The Company reserves the right to cancel the work order forfeiting security deposit if the work is not started within 10 days from the date of receipt of work order and also to terminate the contract at any time if the work is not done with proportionate progress to the satisfaction of the company officials and in all such cases the company will be at liberty together work done in any manner that the company thinks fits and all losses and damage sustain by the company in this regard will be recovered from contractor and his assets.
19. **Liquidated damage:** The work should be completed within the time limit stipulated in the work schedule. 0.5% of the contract amount will be levied per week for delay on your part as liquidated damages, subject to a maximum of 10% of the contract value.
20. The Contractor and his crew can avail Company canteen facility by remitting the cost of coupons or the food items at the rate fixed by Canteen Authority from time to time
21. All workers engaged with the work shall have Police Clearance Certificate (PCC) and other formalities insisted by Security Department of TTPL
22. The tenderer should have **valid ESI, and EPF Registrations** if applicable for participating in the tender
23. **Guarantee:** The tenderer should also provide a guarantee for six months against poor workmanship. 10% of the contract amount will be retained by the company during the guarantee period.
24. Company reserve the right to accept/reject any of the tender after evaluation with or without assigning reason no matter whether a Tenderer has quoted the lowest rate. All questions/ disputes arising out or in connection with this shall be decided by the Managing Director of the Company and his decision thereof shall be final and binding to all tenderers.
25. Any dispute or questions relating to or arising out of the finalization of this tender, if remains, shall be subject to the executive jurisdiction of the courts at Thiruvananthapuram. All statutory deductions will be made from the contractor's bill as per rules.
