3. **Price:** Lumpsum amount for the entire work shall be quoted.
4. **Period:** The work should be completed within **Forty Five Days (company working days)** from the date of issue of Work Order.
5. **The tenderer should have valid ESI and PF registrations and MSME registration if applicable for participating in this tender.**
6. **Pre Qualification Criteria:** Experience of having successfully completed similar works as per the scope of work during last seven years ending 31st March 2021 should be either one of the following:
 - i. Three similar completed works costing not less than the amount equal to Rs.1,25,126/- in a year
 - ii. Two similar completed works costing not less than the amount equal to Rs.1,56,408/- in a year
 - iii. One similar completed works costing not less than the amount equal to Rs.2,50,252/- in a year
7. In support of Clause 6, tenderer should submit the **copy of such work orders along with satisfactory completion certificates.**
8. The tenderer should remit the Earnest Money Deposit (EMD) mentioned in this document in DD and proof of thereof should be enclosed along with the tender. Other mode of remittance will not be accepted.
