3. **Price:** Lumpsum amount for the entire work shall be quoted.
4. **Period:** The work should be completed within **Forty Five Days (company working days)** from the date of issue of Work Order.
5. **The tenderer should have valid ESI and PF registrations and MSME registration if applicable for participating in this tender.**
6. **Pre Qualification Criteria:** Experience of having successfully completed similar works (like concrete works, Steel Fabrication works etc.) as per the scope of work during last seven years ending 31st March 2021 should be either one of the following:
 - i. Three similar completed works costing not less than the amount equal to Rs.1,62,834/- in a year
